NSA-MI ProTrack Registration Agreement

Please initial each item.

I understand the following:

_____ By registering for ProTrack, I am making a 20-month commitment to my professional development.

_____ The tuition for ProTrack is \$1995. Tuition payments are nonrefundable.

_____ A payment plan is available to help me manage my payments. An initial payment of \$995 is due prior to my starting the program. The monthly installments of \$250 for four months following the start of the program are strictly a convenience for me as a participant. These are not pay-for-attendance fees—
_____ I agree to pay the full \$1995 tuition regardless of my level of participation in the program.

_____ If I choose the payment plan, I authorize four monthly payments of \$250 following my initial payment of \$995.

_____ I can receive a 15% discount off of ProTrack fees if I pay the full tuition prior to attending my first session (\$1695).

_____ I understand that ProTrack Directors will consider special circumstances if I need to withdraw once I've started the program within the first 6 months due to serious changes (illness, death in family, change in job, etc.) and that I will be responsible for a \$995 administrative fee.

_____ I understand no refunds will be issued once I've been enrolled in ProTrack for more than 6 months.

_____ I can continue to attend ProTrack sessions for only \$20 per session (covering meal costs) once I've completed the entire curriculum.

_____ ProTrack has a revolving schedule; participants missing a session may make up that session the next time it is offered.
